

## **THE PEBBLES 50<sup>TH</sup> BIRTHDAY CELEBRATION INSTANT WIN GAME**

### **OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.**

**OPEN ONLY TO LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES AND THE DISTRICT OF COLUMBIA WHO ARE AT LEAST EIGHTEEN (18) YEARS OLD AT THE TIME OF ENTRY.**

**VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**

The Pebbles 50<sup>th</sup> Birthday Celebration Instant Win Game ("Promotion") is sponsored by Post Consumer Brands, LLC ("Sponsor"), 20802 Kensington Blvd., Lakeville, MN 55044 and is administered by Prize Logic, LLC, ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

- 1. PROMOTION PERIOD:** The Promotion begins on March 15, 2021 at 12:00 PM (noon) Eastern Time ("ET") and ends on November 30, 2021 at 11:59:59 PM ET ("Promotion Period"). The Administrator's computer is the Promotion's official clock.
- 2. ELIGIBILITY:** This Promotion is offered only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Officers, directors and employees of Sponsor, Administrator, and any of their respective owners, parent companies, affiliates, directors, subsidiaries, franchisees, representatives, advertising, promotion and production agencies, agents (all such individuals and entities collectively referred to herein as the "Promotion Entities") and their immediate family members (*i.e.*, spouse, parent, child, sibling, and the "steps" of each) and persons living in the same household of each are not eligible to participate in the Promotion. Void where prohibited or restricted by law. All federal, state and local laws apply.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein. Entrants and/or potential winners may be required to provide proof of identification and eligibility as required by Sponsor or Administrator.

For purposes of the Promotion, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address. If it is discovered or suspected that an entrant has registered or attempted to register for the Promotion using multiple e-mail addresses or multiple identities, all of that entrant's Game Plays (as defined below) associated with that household (determined by Sponsor and/or Administrator in its sole discretion) may be disqualified and any prize an entrant might have been entitled to win will not be awarded any may be revoked. Use of any automated system or any like methods to participate in the Promotion is prohibited and will result in disqualification of any entrant attempting such use.

- 3. HOW TO PARTICIPATE:** To participate in the Promotion, eligible entrants must obtain either a receipt ("Receipt") or a code ("Code") via the following methods:

A. Make a Purchase: Each individual may purchase one (1) specially marked box of any participating Pebbles cereal (see Appendix for list of participating products) from a participating retailer (each a “Qualifying Purchase”) during the Promotion Period, while supplies last to receive a Receipt. An entrant must save his/her Qualifying Purchase Receipt to participate.

B. Without a Purchase:

i. Mail-in Code Request: To obtain a Code without making a purchase from March 1, 2021 through November 15, 2021, an entrant may legibly hand write his/her full name (no initials), complete street address (no P.O. Box), age, and valid e-mail address on a 3½” x 5” properly stamped postcard and mail it to: The Pebbles 50<sup>th</sup> Birthday Celebration Instant Win Game Code Request, P.O. Box 251328, West Bloomfield, MI 48325. Requests sent in an envelope will not be accepted. Mail-in requests must be postmarked by November 15, 2021 and received by November 25, 2021. Administrator will send one (1) Code per Mail-In Request by e-mail to the e-mail address provided on the request. There is a limit of one (1) Mail-in Request per day during the Promotion Period. Multiple mail-in requests with the same postmark date will be deemed one (1) request. Mail-in requests will not be returned and no further correspondence will be entered into. Mail-in requests must be original and hand-written. No mechanical reproductions are allowed.

ii. Online Code Request: To obtain a Code without making a purchase from 12:00 AM ET on November 16, 2021 to 11:59:59 PM ET on November 30, 2021, an entrant may use the Code LVSBWMBX.

**All Codes and Receipts must be obtained during the Purchase Period.**

During the Promotion Period, after an entrant has obtained a Receipt or a Code, he/she must visit <https://pebblesbirthday.com/> (“Website”) and enter his/her e-mail address. An entrant must then follow the on-screen instructions to register by providing the information requested by Sponsor including, but not limited to, complete first and last name, street address (P.O. Boxes are not permitted), city, state, ZIP code, phone number, date of birth, and confirmation entrant has read and agrees to be bound by these Official Rules.

After completing the registration form, an entrant may follow the instructions on the Website to either upload an image of a Qualifying Purchase Receipt or enter a Code. The entrant may then follow the on-screen instructions to play the instant win game and receive one (1) Game Play. Each Qualifying Purchase Receipt and each Code may only be used once. **A Qualifying Purchase Receipt must be dated during the Promotion Period to be valid. Any Game Play made using a Qualifying Purchase Receipt dated outside of the Promotion Period will be voided and not eligible to win a prize.** Each entrant must circle the Qualifying Purchase item on the original Receipt. The Receipt file must be in .JPEG, .JPG, .PNG, or .GIF format (no PDFs will be accepted) and may not exceed 10 MB.

Regardless of how a Game Play is obtained, after a valid Game Play, the entrant will receive an on-screen notification indicating whether he/she is a potential Instant Win Game prize winner (“Notification”). Each entrant who receives a winning Notification will be deemed a potential Instant Win Game prize winner subject to verification of the entrant’s eligibility and

A "day" is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET on each calendar day during the Promotion Period, except on March 15, 2021, when the day will start at 12:00 noon ET and end at 11:59:59 PM ET. In the event that a household enters the Promotion using more than one (1) unique e-mail addresses, all of the Game Plays associated with that household (determined by Sponsor or Administrator in their sole discretion) may be disqualified. If it is discovered or suspected, in Sponsor's sole discretion, that an entrant plays or attempts to enter more than one (1) Code or Receipt per day to receive more than one (1) Game Play per day, all of that entrant's Game Plays, in Sponsor's sole discretion, may be declared null and void and any prize(s) he/she might have been entitled to will not be awarded to him/her.

**4. PRIZES, ODDS OF WINNING, AND APPROXIMATE RETAIL VALUE ("ARV"):**

**A. Prizes:** There will be three thousand (3,000) total prizes available during the Promotion Period, as set forth below:

**B. Total ARV:** The total ARV of all available prizes in the Promotion is \$46,162.50.

**C. Odds of Winning/Limit:** The odds of winning a prize depend on when the entrant completes a Game Play for the Prize Pool he/she is playing for. Prizes will be made available at random times throughout the Promotion Period for each Prize Pool. To be a potential winner of a prize, an entrant's Game Play must have occurred either at the exact randomly predetermined winning time as determined by Sponsor and/or Administrator. If a Game Play does not occur at the exact randomly predetermined winning time, then the next entrant's Game Play to occur after that time will be deemed a potential prize winner for the respective Prize Pool. **5. HOW TO CLAIM A PRIZE:** All entrants who receive a winning Notification are subject to verification of eligibility and compliance with these Official Rules. Each potential winner will receive an Instant Win Notification on screen and via e-mail, after the completion of a winning Game Play. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR PROMOTION ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED**
