- **1. PROMOTION PERIOD:** The Promotion begins on March 15, 2021 at 12:00 PM (noon) Eastern Time ("ET") and ends on November 30, 2021 at 11:59:59 PM ET ("Promotion Period"). The Administrator's computer is the Promotion's official clock.
- 2. **ELIGIBILITY:** This Promotion is offered only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Officers, directors and employees of Sponsor, Administrator, and any of their respective owners, parent companies, affiliates, directors, subsidiaries, franchisees, representatives, advertising, promotion and production agencies, agents (all such individuals and entities collectively referred to herein as the "Promotion Entities") and their immediate family members (*i.e.*, spouse, parent, child, sibling, and the "steps" of each) and persons living in the same household of each are not eligible to participate in the Promotion. - ii. Online Code Request: To obtain a Code without making a purchase from 12:00 AM ET on November 16, 2021 to 11:59:59 PM ET on November 30, 2021, an entrant may use the Code LVSBWMBX.

All Codes and Receipts must be obtained during the Purchase Period.

During the Promotion Period, after an entrant has obtained a Receipt or a Code, he/she must visit https://pebblesbirthday.com/ ("Website") and enter his/her e-mail address. An entrant must then follow the on-screen instructions to register by providing the information requested by Sponsor including, but not limited to, complete first and last name, street address (P.O. Boxes are not permitted), city, state, ZIP code, phone number, date of birth, and confirmation entrant has read and agrees to be bound by these Official Rules.

After completing the registration form, an entrant may follow the instructions on the Website to either upload an image of a Qualifying Purchase Receipt or enter a Code. The entrant may then follow the on-screen instructions to play the instant win game and receive one (1) Game Play. Each Qualifying Purchase Receipt and each Code may only be used once. A Qualifying Purchase Receipt must be dated during the Promotion Period to be valid. - **B.** Total ARV: The total ARV of all available prizes in the Promotion is \$46,162.50.
- C. Odds of Winning/Limit: The odds of winning a prize depend on when the entrant completes a Game Play for the Prize Pool he/she is playing for.
